

## FORT SCOTT CHRISTIAN HEIGHTS PARENT/STUDENT HANDBOOK

### PHILOSOPHY OF EDUCATION

The philosophy of education of Fort Scott Christian Heights is based upon the premise that parents are responsible under God for the education and training of their children. Therefore, FSCH serves as an extension of the Christian home and was established to provide parents an opportunity for their children to receive academic instruction and character development in an environment free from humanistic philosophies.

There are three areas of development in a child that require special attention. These areas are spiritual, academic, and social. The goals of FSCH are: (1) Encourage all children to incorporate biblical principles in their character development. (2) Make learning a priority in the classroom. (3) Provide quality instruction to prepare children for life, not just how to make a living. (4) Provide activities which will help train and develop students socially. (5) Provide instruction to help students make the decision to accept Jesus Christ as Lord of their lives.

The successful development of a child depends upon the combined effort of home, school, and church working together. A child who achieves academically, desires God's best for their lives, and is prepared for life, will be successful.

The academic program, through the traditional approach, is developed to provide students with the best possible program of studies. The emphasis is upon the mastery of basic facts, as well as the development of the power of reasoning.

### Statement of Social Position

Fort Scott Christian Heights, with the help of the Holy Spirit, seeks to walk in the truth of God's Word, the Bible. We desire to live like Jesus Christ who was full of grace and truth (John 1:14). We believe that God, in His mercy, spares us from what we deserve, and in His grace, He blesses us with what we do not deserve.

We believe that Jesus Christ's death on the cross completely paid for our sins, and His resurrection from the dead proved His victory over sin and death (I Corinthians 15:55-58; Romans 3:21-26). We also believe that since Christians have not only been assured of forgiveness, but also are dead to sin, we should not continue in sin so God can keep forgiving us. We who have died to sin should live in it no longer (Romans 6:1-2). Rather, because of God's great love in sending Jesus to die for us, we ought to live for Him (Romans 5:8). We have been set free from a life of sin. We are no longer slaves to sin, and we are called to not make a practice of sinning (Romans 6:12-13; Galatians 5:1).

It is our belief that many in the world today would seek to exchange the truth of God for a lie (2 Timothy 4:2-4). For this reason, FSCH would like to be clear in our stance regarding several controversial social issues of today. In doing so, we are not saying that these issues, or the sins involved in them, are bigger or worse than any other sins or issues. Sin is sin; and we are called to reject all sin. We specifically address these issues because modern society has both confused and, in some cases, deliberately and intentionally misrepresented what Scripture says regarding these behaviors

**Truth of Scripture:** As we address all issues of life, we believe that the Bible has supreme authority in all matters of faith and conduct. We believe that "all Scripture is God-breathed and is useful for teaching, rebuking, correcting, and training in righteousness so that the man of God may be thoroughly equipped for every good work" (2 Timothy 3:16-17). We believe that the Bible, consisting of the sixty-six books of the Old and New Testament, is the infallible Word of God, inspired by the Holy Spirit, and without error in the original manuscripts (2 Peter 1:21). Because the Bible is true it is the standard of moral goodness (Psalm 19:7-11).

**Relationships:** We believe that all humans are created in the image of God and therefore each individual is highly valuable. As a result, God expects all people to be treated with respect and honor. We are called to love and encourage one another as we strive for unity (Mark 12:29-31; I John 4:19-20; Ephesians 4:1-3). This means that all bullying, whether it is physical, verbal, cyber, written, or relational is sin.

**Gender Identity:** We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God (Genesis 1:26-27). Rejection of one's genetically defined gender is a rejection of the image of God within that person.

**Family structure:** We believe that marriage is a covenantal relationship between one genetically defined man and one genetically defined woman (Genesis 2:24; Matthew 19:4-5). We believe that God created man and woman equally in His image, importance, and value, in God's love and wisdom, they were given unique and complementary roles in marriage as a picture of Christ and the Church (Genesis 1:27; Genesis 2:18; Ephesians 5:22-31).

We believe that God has given the primary responsibility of discipling and teaching children to parents (Deuteronomy 6:4-9; Ephesians 6:1-4; Proverbs 22:6; Psalm 78:1-7). FSCH exists to come alongside parents in this journey to equip, strengthen, confirm, and reinforce biblical teaching at home.

**Sexual purity:** We believe that any sexual activity outside of the marriage bond is sin (Hebrews 13:4). Furthermore, because marriage is a covenantal relationship between one man and one woman, any sexual activity outside of the marriage relationship is defined by the Bible as fornication (Matthew 19:4-5). Fornication is sin. We believe that any form of sexual immorality that deviates from the biblical standard, such as adultery, pornography, homosexual behavior, premarital sex, bisexual conduct, bestiality, any attempt to change one's sex, or disagreement

with one's biological sex, is sinful and offensive to God (1 Corinthians 6:9-10, 13, 18-19; Exodus 20:14; Matthew 15:19; Romans 1:26-27).

**Sanctity of life:** We believe that life is a gift from God and is precious. We believe that life begins at conception (Psalm 139:13-16; Isaiah 44:2a; Isaiah 49:5a) and each person's days are numbered by God (Psalm 139:16; James 4:13-15).

## Doctrinal Statement

We believe in:

the reliability and inspiration of the Bible; the doctrine of the Trinity; the deity of Christ; the value and dignity of man and his sinfulness; the offer of forgiveness of sins and assurance of eternal life as a free gift from God, obtained through faith in Christ; the power of the Holy Spirit to purify the Christian and enable him to live a victorious, holy life; the reality of eternal joy, or eternal punishment after death; and the second coming of Christ.

## ADMISSIONS

### Admissions Policy

Fort Scott Christian Heights admits students of any race, national and ethnic origin to all rights, privileges, programs, and activities generally accorded or made available to students at the school. Any student, who lives a life in accordance with biblical standards of moral purity; who is willing to apply themselves academically; who will obey all the guidelines of the school; and does not have significant, learning disabilities, will be admitted. The standards of this school are moral and ethical, as well as educational. **Parents, by the act of making application for their child, are giving their full cooperation to the administration and teachers in the enforcement of these standards of conduct.**

### Admissions Procedure

The following criteria must be met before a child will be accepted as a student at FSCH.

1. A conference between the parents and the principal which will focus on the following:
  - a. Reason for desiring to attend FSCH.
  - b. Student's learning capabilities.
  - c. Philosophy of school.
  - d. Rules of school.
  
2. An application must be received at least one week before student will be allowed to enroll.

3. An official transcript must be received from previous school attended.
4. Enrollment fees, book fees, and one month's tuition are required to be paid on the first day of enrollment. Book fee is also assessed the first month of the second semester (January).

There will be a 30-day probationary period in which the administration will determine if a student will be accepted on a permanent basis.

### **Admissions Criteria**

Students enrolling for the first time shall provide the school with a complete immunization record as required by the State Health Department. Those enrolling in kindergarten must be five years of age by August 31 and those students enrolling in preschool must be a minimum of four years of age by the August 31. A copy of their birth certificate is also required.

FSCH does not presently have the personnel or resources to work with children who might have significant learning disabilities and/or those who have a history of social or behavioral problems. Therefore, such students will not be accepted.

## **FINANCIAL INFORMATION**

### **Payment Policy**

1. The fees for book rental, workbooks, and enrollment are due on the day of enrollment. These fees are non-refundable.
2. Tuition is charged on a monthly basis for nine months and is due by the 15<sup>th</sup> of each month. Monthly tuition charges are not prorated, therefore attendance during any part of a month will result in a full month's charge.
3. Monthly payments are preferred to be made in nine monthly payments but special arrangements may be made with the principal to make twelve monthly payments.
4. If tuition becomes 30 days past due, then a letter may be sent notifying the parents of the following action: (1) A payment must be received by the end of the current month bringing the account up to date, or (2) Satisfactory arrangements must be made with the principal concerning payment of the account, or (3) If neither payment nor arrangements are made, then the termination of the child's enrollment may result.
5. No records, grade cards, or transcripts will be released until all tuition and fees are paid in full.
6. All past due student tuition accounts must be paid in full before students may enroll for a new school term.

## STANDARDS OF CONDUCT

1. Our Creator gives us life by which we are to glorify Him and your body is to be the temple of the Holy Spirit. Therefore, students are to refrain from the use of alcohol, tobacco, or other illicit drugs at all times whether on or off the school property. Any student found with any of these items in their possession may be subject to dismissal from school.
2. Any indecent or immoral action, conversation, writing or any assistance given to such action will not be tolerated and may be grounds for dismissal. **All** behavior must be in agreement with biblical principles of morality.
3. Any student responsible for defacement, loss, or breakage of school property as a result of carelessness or improper behavior will be held financially responsible for repairing or replacing the property.
4. Students need to be mindful that they represent Christ and Fort Scott Christian Heights at all times. Students' public presence on social media should reflect Christ and FSCH in a positive way.
5. Lunch hours are closed and a student may leave campus only in the presence of a parent or approved adult. No outside visitors are allowed during the lunch time except with prior approval from the office. (Parents do not need approval.)
6. No snacks of any kind will be allowed to be taken to chapel. This includes the chewing of gum.
7. Students will not be allowed to leave campus during school hours except by special permission from the office.
8. Students will not be allowed to play with any type of balls in the auditorium except during physical education activities or during lunch time when the weather is inclement.
9. No electronic devices used for music or games will be allowed in the school building or on school functions. Laptops are to be used only for class assignments.
10. Cell Phone Policy: All cell phones (electronic communication devices) must not be visible and must be turned off during school hours. There will be no tolerance for the use of any device which has the capability of communicating with another device.
  - A. The first offense will result in the confiscation of the device and will be kept in the office until school is dismissed. The student using the device will be given one demerit and if the phone belongs to another student that student will also receive one demerit.
  - B. The second offense will result in the device being confiscated and will only be released to a parent or guardian. The students involved will receive two demerits.

## DRESS CODE

**The standard of appearance for students of FSCH is based on three principles: modesty, neatness and appropriateness.** A student's clothing and appearance should always be pleasing and not draw undue attention to oneself, thus emphasizing the more important qualities of personality and character. Parents are responsible to ensure that students comply with daily dress code standards. The dress code is in effect at school and at all school-related functions including sporting events away from school.

### Female Students (7-12)

1. All dresses and shirts must have sleeves which are long enough to ensure the underarm is covered. Shirts must be long enough in order to cover the midriff when sitting, bending, standing or raising the hand. Necklines on shirts and dresses must be modest in every position. (Not lower than four closed fingers from the base of the neck). Shirts must not be over-sized or too tight. Shirts must be free of inappropriate pictures, slogans or designs.
2. Skirt length must be long enough to reach the knee when standing or sitting. No part of the leg above the knee should be exposed at any time. No tight skirts will be allowed. Splits in skirts will not be allowed to be higher than the knee. Leg wear cannot be used as a substitution for proper skirt/dress length.
3. Jeans and slacks will be allowed in the classroom. All pants must be neatly fitted. Pants are not to be baggy, dragging the floor or too tight (skinny jeans). Rips and tears must be patched so that no bare skin is exposed above the knee. Capri length pants are permitted. Pajama pants are not allowed.
4. The PE uniform will consist of a comfortable shirt, athletic shorts (not tight fitting) with a length long enough to reach the knees, athletic pants/ sweatpants or a long skirt and tennis shoes. PE shorts must be school approved. Students must have a written note from parents if they cannot wear their PE clothes in order to receive full credit for the day.
5. Shorts and PE attire are not allowed in the classroom.
6. Shoes must be worn at all times. Flip-flops, slides or bedroom slippers are not allowed.

7. Minimal jewelry is permitted as is nail polish. One set of earrings is permitted; however, plugs/gauges and other facial and body piercing are not allowed. At any time, faculty or administration may request that jewelry be removed if it becomes distracting or poses a safety hazard. Tattoos are discouraged. Any existing tattoos should be covered at all times. Makeup should not be excessive and should only enhance natural beauty and not detract from it. Only natural hair color is allowed.

8. Every Monday is designated as dress-up day. No tee shirts (long or short sleeved), sweatshirts or tennis shoes will be allowed. If a coat is needed, it must not be made of denim or sweat-shirt material. No hoodies are allowed. No writing across the front or back or camouflage design will be acceptable. Blue jeans or blue denim skirts are not allowed. Dress-up rules are in effect for all programs and as deemed necessary by teachers or administration for other functions.

9. All banquet dresses must meet school dress code.

### **Male Students (7-12)**

1. All shirts must have sleeves which will not reveal the underarm when the hand is raised. Only tee shirts which are designed as outer wear will be allowed (no white undershirts). Shirts must be free of inappropriate pictures, slogans or designs.

2. All jeans or slacks must be full length and neatly fitted. Pants are not to be baggy, dragging the floor or too tight (skinny jeans). Rips and tears must be patched so that no bare skin is exposed above the knee. Shorts, wind pants and sweatpants are only to be worn during PE class. Pajama pants are not allowed.

3. Boys are required to shave as often as necessary in order to be neat in appearance. No long sideburns, beards or mustaches will be allowed. Hair needs to be cut to clear the collar and neatly trimmed around ears. **Hair** is not to be lower than the eyebrows.

4. Minimal jewelry is permitted; however, piercings of any type are not allowed. At any time, faculty or administration may request that jewelry be removed if it becomes distracting or poses a safety hazard. Makeup and nail polish are not allowed. Tattoos are discouraged. Any existing tattoos should be covered at all times. Only natural hair color is allowed.

5. Shoes are to be worn at all times. Flip-flops, slides or bedroom slippers are not allowed.
  
6. The PE uniform will consist of a comfortable shirt, and choice of knee length athletic shorts (not tight fitting), wind pants or sweatpants and tennis shoes. PE shorts must be school approved. Students must have a written note from parents if they cannot wear their PE clothes in order to receive full credit for the day.
  
7. Every Thursday is designated as dress-up day. No blue jeans, tee shirts (long or short sleeved), hoodies, sweatshirts, or tennis shoes will be allowed. All shirts must have buttons. If a coat is needed, it must not be made of denim or sweatshirt material. No writing across the front or back or camouflage design will be acceptable. Dress-up rules are in effect for all programs and as deemed necessary by teachers or administration for other functions.

### **Dress Code Violations**

FSCH depends on our parents to work with the school in maintaining this dress code by checking your child before he or she leaves for school, and making sure he or she is dressed and groomed properly. It is understood that enrollment at FSCH means a pledge on the part of both parents and students to abide by this dress code.

Students who are not in compliance with dress code guidelines will be given the opportunity to change into something that resolves the issue and will be asked to make a different choice in the future. This is considered a verbal warning. Students who repeatedly violate this dress code will be given a demerit and asked to change or remain in the office until a parent brings appropriate clothing. Students are considered absent from class without excuse for any time spent in the office because of a dress code violation. If a student consistently violates this dress policy, their parents will be called for a conference with administration.

The administration reserves the right to make discretionary judgment regarding the appropriateness of student dress, hair, and fashion not explicitly covered in this dress code. The final interpretation of this code remains the responsibility of the administration.

### **ATTENDANCE**

Our school highly values class time as a significant part of our curriculum in awarding credit for any course. Absences totaling more than eight days in a semester may cancel units of credit or result in dismissal from school. There will be an exception made if the student can show in writing that the absences were unavoidable. This may require a letter from a physician. There will be a letter mailed to the parent after six absences in a semester, and more than eight absences in a semester will require a conference between parents and the principal.



Students are expected to be in school except in cases of emergency or for reasons as explained below:

1. Personal illness or accident - The school may require the certificate of a doctor if it is deemed advisable.
2. Illness in the family.
3. Death of a relative.

Steps to follow when absent:

1. Have parent or guardian phone the school and inform the office of your absence before 10:00 a.m. of the day of your absence.
2. The day following the absence, the student must report to the office and obtain an admit slip. The office will determine if the absence is excused or unexcused.
3. Ask all teachers for make-up assignments if the absence is excused. (Each student is responsible for seeing that make-up work is completed.)
4. If the absence is not excused, there will be zeroes given in each class and no opportunity given for make-up work.

Any student enrolled in FSCH will be required to attend a full school day and be enrolled in at least five core classes including Bible class. A senior may enroll in one college class per semester and receive dual credits.

## **ATHLETIC COMPETITION ELIGIBILITY**

**In** order for a student to be eligible to participate in athletic competition for the succeeding quarter, they must meet the following criteria for each quarter. First quarter affects second quarter, second quarter affects third quarter, third quarter affects fourth quarter, and fourth quarter affects the first quarter of the next year.

1. A student cannot be on probationary status, either academically or behaviorally.
2. A student must have an overall C average in their core classes (excluding band, choir, PE, and journalism).
3. A student must not have a failing grade **in** any class for the quarter.

## **ANTI-BULLYING POLICY**

All students have the right to go about their daily lives without the fear of being threatened, assaulted, or harassed. FSCH is committed to providing a caring, friendly, and safe environment for all our students so they can learn in a relaxed and secure atmosphere, free from oppression and abuse. All types of bullying are unacceptable and will not be tolerated. Isolated instances of hurtful behavior, teasing, or arguments between individuals would not be seen as bullying.

**Definition: Any intentional gesture or any intentional written, verbal, electronic, or physical act or threat towards an individual that is sufficiently severe, persistent, or pervasive that would create an intimidating, threatening, or abusive educational environment.** (Taken from K.S.A. 72-8256)

Forms of bullying:

Verbal: name calling, teasing, put-downs, threats, spreading rumors, racist remarks

Physical: pushing, hitting, slapping, kicking, destroying property or any other form of violence

Social: ostracism or exclusion, ignoring, being unfriendly, hiding property

Cyber: all areas of internet use including social networking websites, nasty and/or threatening emails, misuse of blogs, gaming websites, instant messaging, and mobile threats by text message, inappropriate pictures or videos

Any act that insults or demeans an individual in such a way as to cause distress, reluctance to attend school, a decline in work standards or problem behaviors will be considered as bullying. Students who violate this policy will be subject to disciplinary action, up to, and including suspension or expulsion.

## **DISCIPLINE POLICY**

This policy is primarily designed to be used as effective discipline control in grades 7-12.

Demerits will be given at the discretion of each teacher to any student who has violated school or classroom rules. The number of demerits given will depend upon the seriousness of the offense. (More than one demerit per offense will need to be approved by the principal.) All demerits given are subject to the review of the principal.

5 Demerits: A student is required to spend one-half hour in detention after school.

10 Demerits: A report is sent to the parents listing all offenses and the student will serve a one-hour detention after school and meet with the principal.

15 Demerits: A conference between the principal and parents will be required. The student will be required to serve one hour detention and will not be allowed to participate in any extra-curricular activities for a nine-week period. This would include sports, parties, field trips etc.

The demerits will accumulate for a semester. At the beginning of each semester, all demerits will be erased, but the extra-curricular prohibition may continue into the second semester.

If a student reaches the 15-demerit level for both semesters, it is evident that the student is not willing to follow the school guidelines, therefore, the student may not be allowed to enroll the following year.

### **Rewards**

A student will receive one personal day per semester if they have no demerits and less than two absences in that semester.

### Honor Roll

A Honor Roll: To achieve the A honor roll, a student must have all A's in their academic subjects.

A-B Honor Roll: To achieve the A-B honor roll, a student must have only A's and B's in their academic subjects.

Semester honor roll will be based on a percentage average of the two nine-week grades for each class.

The year-end honor roll will be based on the two semester grades for each class. A student who receives a C for a semester will not be eligible for the year end honor roll.

### Standardized Tests

Standardized testing will be administered every other year to students in grades 1-12. Seniors are strongly encouraged to take the ACT test.

### Graduation Awards

To be eligible to receive the salutatorian award and wear the honor cord, a student must have a minimum overall average of 92%. To be eligible to receive the valedictorian award, a student must have a minimum overall average of 95%. To be eligible for either award, a student must have attended FSCH for a minimum of the last three semesters.

### Senior Trip

The senior class is allowed 4 excused school days for a trip. The expenses for the trip will be raised by the seniors throughout their high school years. The sponsor for the trip will be approved by the principal. If a student enrolls in FSCH their senior year, in order for this student to be eligible for participation on the trip, he or she must contribute an equal share of the monies which have been previously raised.

## GRADUATION REQUIREMENTS

Each student will be eligible for graduation after the completion of a minimum of 21 units with the addition of 1/4 unit of Bible for every semester enrolled in FSCH. The following requirements are based on the Kansas Board of Regents pre-college curriculum. A student who has not completed the required number of academic units will not be eligible to receive a diploma and therefore will not be allowed to participate in the commencement exercises.

## **PARENT RESPONSIBILITIES**

### **Parent/Teacher Conferences**

Parents of elementary students are required to schedule a conference with their child's teacher during the week immediately following the first quarter. Parents of students in grades 7-12 are strongly encouraged to meet with their child's teachers. One evening, usually Tuesday or Thursday, of the week following the first quarter are scheduled for parent/teacher conferences. Communication between parents and teacher is vitally important, however, when a conference becomes necessary it must be scheduled. For a parent to walk into a classroom and demand an immediate conference is not acceptable. Teachers are willing to schedule conferences in order to work out any problems.

### **Homework/Makeup Work**

The philosophy of the elementary department is that homework will be minimal. However, when there are occasions when it is necessary, the teachers expect the parent's cooperation and understanding at these times. Parents and teachers must appear to the child as a team. When your child is sick and misses school for more than one day, it is the parent's responsibility to make an appointment with the classroom teacher and pick up their assignments. This must be done when the teacher has adequate time to assemble the assignments.

### **Parent Teacher Fellowship (PTF)**

PTF is an organization which is comprised of parents, teachers, and friends, and is responsible for major fund-raising functions. The funds raised are primarily used for special projects and needs of the school. Parent participation is highly encouraged.

## **DONATIONS AND GIFTS**

The monies which are received from tuition and fees only cover approximately 45% of the total operating budget. The low tuition cost enables more Christian parents to enroll their children in FSCH. In order to cover the deficit, there is a need to receive cash donations as well as other gifts. All donations are tax deductible.

## **LIABILITY INSURANCE**

In case of injury to a student which requires medical attention, FSCH's liability insurance is secondary coverage. This means that only if a parent does not have medical insurance or has a deductible will the school's insurance pay.

## MISCELLANEOUS

**I. Lunch** - FSCH does not offer a hot lunch program. There are microwaves available at the school for students to warm lunches that they bring from home.

**II. Elementary Parties** - There are usually four class parties during the school year: the fall party, Christmas party, Valentine's party, and spring party. If a parent has an objection to or a personal conviction against any of these parties, they are allowed to remove their child from the school for that time. If a parent is unable to remove their child from school, the teacher will not be expected to isolate the child from the party activities.

**III. Head Lice** - If a child is discovered to have head lice, the parent will be notified immediately and expected to pick the child up and begin treatment. The child will not be allowed back in the classroom until the school secretary or the teacher has checked the child's head. The only time that all parents will be informed is in the event of several cases being reported.

**IV. School Day** - For grades 1-12, classes will begin at 8:00 A.M. and will be dismissed at 3:45 P.M. Monday through Thursday. There will be no classes on Friday except as possible makeup days for inclement weather. Students will be allowed to enter the building at 7:50 A.M. and are expected to be out of the building by 4:00 P.M. Due to staff limitations, FSCH cannot be responsible for student supervision for those students who arrive earlier than 7:50 or remain on school property after 4:00. (This does not apply to those students who remain at school because of approved school activities.) Kindergarten class will begin at 8:00 A.M. and will be dismissed at 12:15 P.M. Preschool class begins at 1:00P.M. and dismisses at 3:45 on Monday, Tuesday & Thursday.
